- 1. With reference to the pilot implementation of the Induction Program for Beginning Teachers (IPBT), as per DepEd Order No. 43 s. 2017, titled "Teacher Induction Program Policy", and DepEd Memorandum dated January 21, 2022, which pertains to the "Orientation on the Implementation of IPBT", the Regional Office O2 through the Human Resource Development Division- National Educators Academy of the Philippines, shall monitor, evaluate and provide Technical Assistance to SDO Batanes through virtual meeting (https://meet.google.com/qth-bryv-trm) on September 25, 2023.
- 2. The expected participants in the morning session scheduled to start at 8:00 a.m. include the CID chief, SGOD chief, SEPS and EPSp II -HRD, and all school heads from both elementary and secondary. While in the afternoon session starting at 1:30 p.m. are the IPBT mentors of all schools.
- 3. Schools that have teacher-mentors with scheduled classes on the designated date and time should implement emergency classroom programs to prevent any disruption of classes.
- 4. For participants who do not have internet connectivity at their respective schools, they are encouraged to attend the nearest schools equipped with internet access.
- 5. For information and compliance.




