DIVISION CAPABILITY TRAINING ON THE PREPARATION OF INDIVIDUALIZED EDUCATION PLANS (IEP) FOR LEARNERS WITH SPECIAL NEEDS IN THE REGULAR CLASSROOMS

- 1. To strengthen Inclusive Education practices, this Division, through the Curriculum Implementation Division, shall conduct a Division Capability Training on the Preparation of Individualized Education Plans (IEP) for Learners with Special Needs in the Regular Classrooms on September 12-14, 2025, at Valugan Integrated School Covered Court.
- 2. The training aims to equip receiving teachers in the inclusive classrooms with the necessary knowledge and skills to effectively prepare and implement IEPs responsive to the unique needs of learners with special needs.
- 3. Specifically, the training shall:
 - a. Deepen teachers' understanding of policies on IEP;
 - b. Develop teachers' competence in assessing learners' needs and setting appropriate goals;
 - c. Guide teachers in crafting functional and realistic IEPs aligned with the curriculum; and
 - d. Strengthen collaboration among SNEd coordinators, regular teachers, parents, and other stakeholders.
- 3. Participants in this training are selected regular classroom teachers who are currently handling, or will be assigned to handle, learners with special needs, SPED coordinators, and other relevant personnel identified in the enclosed list of participants. (see Enclosure 1)
- 4. All teachers involved in the conduct of this activity shall be entitled to service credits as per DO # 53,s. 2003, while non-teaching personnel shall earn Compensatory Time Off (CTO)per CSC & DBM Joint Circular No.2, s.2004 to cover services rendered for Saturdays, Sundays, and Holidays.
