ON-SITE MONITORING AND EVALUATION CUM PROVISION OF TECHNICAL ASSISTANCE ON THE IMPLEMENTATION OF IPBT AND OTHER PAPS

1. In support with DepEd Order No. 43, s. 2017 titled, *Teacher Induction Program Policy*, and Regional Memorandum No. 096, s. 2025, this office through the Human Resource Development Section along with the HRDD-NEAP RO2 shall monitor and evaluate the implementation of the Induction Program for Beginning Teachers and other related HRD Programs, Activities, and Projects (PAPs) on **March 10 – 13, 2025**.
2. The said activity aims to:
 - a. ensure effective program implementation and alignment with policy standards across all monitored PAPs
 - b. assess the delivery of induction activities, growth and competency development of beginning teachers, and impact of other PAPs on teacher capacity-building
 - c. identify strengths, gaps, and areas for improvement in both the IPBT and other PAPs; and,
 - d. gather feedback from implementers to support data-driven decision-making, ensuring that the IPBT and other PAPs effectively contribute to teacher readiness, professional growth and overall educational outcomes.
3. As such, all schools, through their IPBT focal persons and IPBT recipients are requested to prepare the necessary documents/portfolio, monitoring reports, and/or accomplishments reports to serve as basis on the provision of Technical Assistance and the Monitoring and Evaluation mechanism.
4. Details of the on-site monitoring are provided in *Enclosure 1*.
5. Meals, accommodation, and mobilization/contingency of the RO Monitors shall be charged against downloaded funds while local participants' meals and other incidental expenses shall be charged to local funds/School MOOE subject to the usual accounting and auditing rules and regulations.

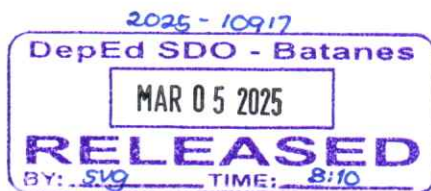
