**ADMINISTRATION OF NATIONAL ACHIEVEMENT TEST
FOR GRADE 6 (NAT 6) FOR SCHOOL YEAR 2024-2025**

1. Pursuant to DepEd Order (DO) No. 55 s. 2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, the Schools Division Office of Batanes through the CID will administer the **National Achievement Test for Grade 6 (NAT 6)** for School Year (SY) 2024-2025 on March 31, 2025,
2. The **NAT 6** is an exit assessment that is designed to determine if grade 6 learners met the standards in the elementary curriculum. The test design measures five learning areas (**English, Mathematics, Science Filipino and Araling Panlipunan**).
3. All currently enrolled Grade 6 learners in public and private schools will take the test through a pen and paper-based modality.
4. The language of testing for the following learning areas are as follows:

Language of testing	Learning Areas
English	English, Science, Mathematics
Filipino	Filipino, Araling Panlipunan

5. Relative to the conduct of NAT 6, a Division Virtual Orientation will be conducted on **March 18, 2025 at 2 o'clock in the afternoon** through this link <https://tinyurl.com/NAT2025-Orientation>. Participants to this orientation are the Room Examiners, Chief Examiners and Room Supervisors.

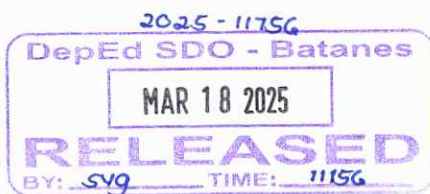
